- 5 year Limited Warranty on all Hardware Components (from date of purchase).

- 2 year Limited Warranty on all Electronics (from date of purchase).

This limited warranty covers defects in materials and workmanship in this product.

What is Not Covered

This limited warranty does not cover any damage, deterioration or malfunction resulting from failure to correctly install or set the product, any alteration, modification, improper or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, power surges, or other acts of nature. This limited warranty does not cover any damage, deterioration or malfunction resulting from the installation or removal of this product, any unauthorized tampering with this product, any repairs attempted by anyone unauthorized by Martec Distribution to make such repairs, or any other cause which does not relate directly to a defect in materials and/or workmanship of this product. This limited warranty does not cover any third-party equipment enclosures, cables or accessories used in conjunction with this product.

Without limiting any other exclusion herein, Martec Distribution does not warrant that the product covered hereby, including, without limitation, the technology and/or integrated circuit(s) included in the product, will not become obsolete or that such items are or will remain compatible with any other product or technology with which the product may be used.

Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

What Martec Distribution Will Do

Martec Distribution will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labour to complete the repair and restore this product to its proper operating condition. Martec Distribution will also pay the shipping costs necessary to return this product once the repair is complete.
2. Replace this product with a direct replacement or with a similar product deemed by Martec Distribution to perform substantially the same function as the original product.
3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.

What Martec Distribution Will Not Do Under This Limited Warranty

If this product is returned to Martec Distribution the shipping charges are to be prepaid by you. Martec Distribution will not be responsible for any costs related to the removal or re-installation of this product. Martec Distribution will not be responsible for any costs related to any setting up of this product, any adjustment of user controls or any programming required for a specific installation of this product.

How to Obtain A Remedy Under This Limited Warranty

To obtain a remedy under this limited warranty, you must contact the authorised Martec Distribution reseller from whom you purchased this product. In order to pursue any remedy under this limited warranty, you must possess an original, dated receipt as proof of purchase from an authorised Martec Distribution reseller. You may also be directed to an authorised reseller or a person authorised by Martec Distribution to repair the product. If it is decided that this product should be returned directly to Martec Distribution or an authorised reseller for inspection or repair, this product should be properly packed for shipping, and all shipping and insurance costs shall be prepaid by you as detailed above under **What Martec Distribution Will Not Do Under This Limited Warranty**.

Before any action or remedy is undertaken, inspection of product may be required to determine if the product is indeed faulty, and if found faulty, whether the faults found are covered by this limited warranty.
